Invitation to Bid for the Supply, Delivery and Installation of One (1) Lot of Information and Communication Technology (ICT) Active Components

The National Privacy Commission (NPC), through the authorized appropriations under the FY 2017 General Appropriations Act intends to apply the sum of Twelve Million Five Hundred Forty-Two Thousand Five Hundred Pesos (₱12,542,500.00) being the Approved Budget for the Contract (ABC) to payments under the contract for the supply, delivery and installation of Information and Communication Technology (ICT) Active Components. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The NPC now invites bids for the supply, delivery and installation of one (1) lot procurement of Information and Communication Technology (ICT) Active Components. Delivery of the goods is required within sixty (60) calendar days after the issuance of the Notice to Proceed. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II of the Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.

Interested bidders may obtain further information from **NPC** and inspect the Bidding Documents at the address given below during office days between **8:00 A.M. and 5:00 P.M**.

A complete set of **Bidding Documents** may be purchased by interested **Bidders** on **23 September 2017** from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of Twenty-Five Thousand Pesos (PhP25,000.00).

It may also be downloaded free of charge from the website of the **Philippine Government Electronic Procurement System (PhilGEPS)** and the website of the **NPC**, provided that Bidders

shall pay the non-refundable fee for the Bidding Documents not later than the submission of their bids.

The **NPC** will hold a **Pre-Bid Conference** on **02 October 2017** at **2:00 P.M.** (**PST**), Meeting Room 1, Level 2, Core G, GSIS Headquarters Building, Financial Center Area, Pasay City, Metro Manila, which shall be open to prospective bidders.

Bids must be duly received by the BAC Secretariat at the address below **on or before 12:00 NN** (**PST**), **16 October 2017**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause **Error! Reference source not found.**

Bid opening shall be at **2:00 P.M. (PST)**, **16 October 2017** at Meeting Room 1, Level 2, Core G, GSIS Headquarters Bldg., Financial Center Area, Pasay City, Metro Manila. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The **NPC** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders
