**RECOMMENDING THE AWARD FOR THE TECHNICAL FACILITATORS RE:  
REVIEW AND ASSESSMENT OF THE FY 2020 YEAR-END PERFORMANCE AND  
FY 2021 TARGET INDICATORS**

**WHEREAS**, the National Privacy Commission (NPC), is the agency mandated to enforce data privacy protection;

**WHEREAS**, in order to fulfill its mandate, the NPC craft comprehensive plans and programs necessitating the conduct of the review and assessment of the FY 2020 year-end performance and FY2021 target indicators to which a technical facilitator is needed. Thus, the same was allocated in the 2020 Annual Procurement Plan (APP) under APP Item No. 2020-0181 with an Approved Budget for the Contract (ABC) amounting to Php120,000.00;

**WHEREAS**, Section 53.9 of the Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 recognizes Small Value Procurement as a method of procuring goods where the amount involved does not exceed the threshold prescribed in Annex "H" of the IRR, provided, that in case of goods, the procurement does not fall under shopping in Section 52 of this IRR;

**WHEREAS**, a Request for Quotation (RFQ) was posted in the PhilGEPS and NPC website as well as the NPC bulletin board, and was likewise sent to five (5) suppliers, namely: Advanced Learning Programs, Ms. Kathrina L. Sta Maria, Project Management Institute, Philippines, Guthrie-Jensen Consultants, Inc. and SGS S.A. However, only Ms. Kathrina L. Sta. Maria submitted her bid;

**WHEREAS**, the BAC members proceeded to evaluate the lone bid and determined that the quotation sent by Ms. Kathrina L. Sta. Maria is the single calculated and responsive quotation at a bid price of Php120,000.00, passing the technical, legal and financial requirements mandated under Republic Act No. 9184 (R.A. 9184) otherwise known as the Government Procurement Reform Act;

**NOW, THEREFORE**, for and in consideration of the foregoing, WE, the members of the NPC-BAC hereby RESOLVE, as it is hereby RESOLVED, to recommend the award for the

Technical Facilitators re: Review and Assessment of the FY 2020 Year-end Performance and FY 2021 Target Indicators to Ms. Kathrina L. Sta. Maria, with the single calculated and responsive quotation in the total amount of One Hundred Twenty Thousand and 0/100 Pesos (Php120,000.00).




