**RECOMMENDING THE AWARD OF CONTRACT FOR THE PROCUREMENT OF
DISINFECTION SERVICES FOR THE NATIONAL PRIVACY COMMISSION**

WHEREAS, the National Privacy Commission (NPC), approved its FY 2021 Annual Procurement Plan (APP) which includes the procurement of disinfection services under APP Item Number 2021-0105;

WHEREAS, the procurement of disinfection services is in compliance with the health and safety protocols recommended by the COVID-19 Inter-Agency Task Force for the Management of Emerging Infectious Diseases (IATF-EID) and CSC Resolution No. 2000912 which was circularized via CSC Memorandum Circular No. 18, S. 2020, requiring the disinfection of government offices adopting alternative work arrangement, particularly those allowing skeleton workforce;

WHEREAS, Section 53.9 of the revised Implementing Rules and Regulations (IRR) of R.A. 9184 recognizes Small Value Procurement (SVP) as a mode of procurement for goods where the amount does not exceed One Million Pesos (Php1,000,000.00);

WHEREAS, a Request for Quotation was posted in the PhilGEPs website, NPC website, and the NPC bulletin board on 16 March 2021, and was likewise sent to three suppliers, namely, Calf Tech Pest Control, Power House Pest Control, and D-Three Pest Management Services, via electronic mail. Four (4) bidders submitted their quotation but two of them failed to pass the required eligibility, thereby leaving only two (2) eligible bidders;

WHEREAS, on 24 March 2021, the National Privacy Commission-Bids and Awards Committee (NPC-BAC) proceeded to evaluate the submitted quotations by Power House Pest Control Services and D-Three Pest Management Services and determined that both bidders passed all the technical, legal, and financial requirements mandated under R.A. No. 9184;

WHEREAS, Power House Pest Control Services has a bid price of Php247,770.00, while D-Three Pest Management Services has a bid price of Php249,984.00, effectively making Power House Pest Control the bidder with the lowest calculated and responsive quotation;

NOW, THEREFORE, for and in consideration of the foregoing, WE, the members of the NPC-BAC, hereby RESOLVE, as it is hereby RESOLVED, to recommend the award for the procurement of Disinfection Services to **Power House Pest Control Services** having the lowest calculated and responsive quotation in the total amount of **Two Hundred Forty-seven Thousand, Seven Hundred Seventy and 0/100 Pesos (Php247,770.00)**.


