**Deed of Undertaking for the Provisional Accreditation
As Institutional Privacy Trainer pursuant to the Training the Trainers
Program**

I _____, of legal age, with business address at _____, Philippines, after being sworn to in accordance with law, depose and state:

1. That I am the Authorized Representative of _____, (state type of entity if public or private), with office address at _____ (“Institution”);
2. That the Institution is applying as an Institutional Privacy Trainer (IPT) pursuant to the National Privacy Commission’s Training the Trainers Program (T3 Program);
3. That the Institution understands that a provisional accreditation is subject to restrictions, qualifications, and continuing requirements as may be provided by the NPC;
4. That as part of its application, the Institution undertakes the following representations:
 - a. That I, as the Authorized Representative, personally accomplished the Application for Provisional Accreditation as Institutional Privacy Trainer and this Undertaking;
 - b. That all the information I have provided are true, correct and complete statements pursuant to the provisions of pertinent laws, rules and regulations of the Republic of the Philippines;
 - c. That I understand any misrepresentations made by me shall cause the disapproval of the Institution’s application and/or outright revocation of the eligibility granted without prejudice to the filing of administrative/criminal case/s against me and/or the Institution;
 - d. To submit a Training Curriculum with course description, objectives and syllabi patterned after existing NPC Data Protection Officers (“DPO”) Accountability, Compliance and Ethics (“ACE”) Level 1 Training and Certification Program;
 - e. To educate, train or instruct three hundred (300) individuals, within the duration of the period of the provisional accreditation, to the best of my capacity;
 - f. To ensure that at least eighty percent (80%) of individuals that I will train will undergo the DPO ACE Certification Examinations;
 - g. To submit reports to NPC as may be required under the T3 Program;
 - h. To provide NPC with training schedules, meeting links and other means to allow NPC to periodically observe training sessions upon prior notice;
 - i. To undergo trainings, seminars and other capacity-building activities as may be instructed by NPC as part of the T3 Program; and
 - j. To ensure my full compliance and cooperation with the NPC on all matters relevant to the T3 Program.
