RECOMMENDING THE AWARD FOR THE PROCUREMENT  
OF TECHNICAL CONSULTANT - WRITER

---

**WHEREAS**, the National Privacy Commission (NPC), is an independent body mandated to administer and implement Republic Act (R.A.) No. 10173 or the “Data Privacy Act of 2012” and to monitor and ensure compliance of the country with international standards set for data protection;

**WHEREAS**, one of the main responsibilities of the National Privacy Commission (NPC) is to “publish, on a regular basis, a guide to all laws relating to data protection (RA 10173, Chapter II, Sec. 7(g)” and to ensure proper and speedy information dissemination to the ever-growing number of stakeholders, both local and international;

**WHEREAS**, to continue the publication of monthly articles and to serve as the direct line of communication to local sectors and the international privacy ecosystem, it is therefore necessary, both for the success of the DPO Journal and the maintenance of the highest quality of its operations, to engage the services of a technical consultant writer;

**WHEREAS**, the Technical Consultant Writer for the Office of the Privacy Commissioner shall undertake the functions indicated in the Terms of Reference;

**WHEREAS**, said procurement is reflected and has been approved in the Commission’s CY 2021 Annual Procurement Plan (APP) under APP Item Number 2021-0107 with an Approved Budget for the Contract (ABC) amounting to One Hundred Fifty Thousand and 0/100 Pesos (Php150,000.00);

**WHEREAS**, the procurement is hinged on Sec. 53.7 of the Implementing Rules and Regulations (IRR) of Republic Act No. 9184 (R.A. 9184), otherwise known as Government Procurement Reform Act, providing for the engagement of individual consultants for no more than six (6) months to do work that is highly technical or proprietary;

**WHEREAS**, the NPC Bids and Awards Committee (BAC) Secretariat sent a Request for Quotation (RFQ) to *Ms. Janina C. Lim* on 03 November 2021;

**WHEREAS**, after evaluation of the qualifications and documentary submissions of *Ms. Janina C. Lim*, the NPC-BAC determined that she fully qualifies as a Highly Technical Consultant to perform the functions required under the Terms of Reference;

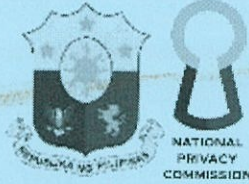




