**RECOMMENDING THE AWARD FOR THE PROCUREMENT
OF TECHNICAL CONSULTANT - WRITER**

WHEREAS, the National Privacy Commission (NPC), is an independent body mandated to administer and implement Republic Act (R.A.) No. 10173 or the "Data Privacy Act of 2012" and to monitor and ensure compliance of the country with international standards set for data protection;

WHEREAS, there is a need to hire a Technical Consultant who is knowledgeable in the nuances of editing pieces for the business community and the general public and who can facilitate the publication of consistently informative and concise articles in the DPO Journal, the NPC's monthly publication which serves as a repository for much-needed sector-specific articles and related information on data privacy for the education of all the stakeholders of the NPC, as well as those in the global privacy community;

WHEREAS, the Technical Consultant Writer for the Office of the Privacy Commissioner shall undertake the functions indicated in the Terms of Reference;

WHEREAS, said procurement is reflected and has been approved in the Commission's FY 2021 Annual Procurement Plan (APP) under APP Item Number 2021-0108 with an Approved Budget for the Contract (ABC) amounting to Two Hundred Fifty Thousand and 0/100 Pesos (Php250,000.00);

WHEREAS, the procurement is hinged on Sec. 53.7 of the Implementing Rules and Regulations (IRR) of Republic Act No. 9184 (R.A. 9184), otherwise known as Government Procurement Reform Act, providing for the engagement of individual consultants for no more than six (6) months to do work that is highly technical or proprietary;

WHEREAS, the NPC Bids and Awards Committee (BAC) Secretariat sent a Request for Quotation (RFQ) to *Mr. Juan V. Sarmiento, Jr.* on 03 November 2021;

WHEREAS, after evaluation of the qualifications and documentary submissions of *Mr. Juan V. Sarmiento, Jr.*, the NPC-BAC determined that he fully qualifies as a Highly Technical Consultant to perform the functions as required under the Terms of Reference;

WHEREAS, payment shall be made monthly in the amount of Fifty Thousand Pesos (Php50,000.00) for a contract period of four (4) months;

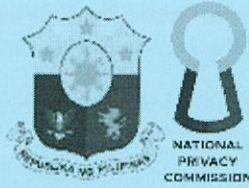


