TERMS OF REFERENCE FOR THE PROCUREMENT OF PORTABLE DISPLAY SYSTEM

I. BACKGROUND

The National Privacy Commission (NPC) is mandated to administer and implement the Data Privacy Act of 2012 (DPA). NPC is also tasked to inform and educate the public on data privacy, data protection and fair information rights and responsibilities as stated in the Section 9.c of the Implementing Rules and Regulations of DPA.

The Public Assistance and Information Division (PIAD) is responsible for information management, including publications and website maintenance, and the provision of public services in the Commission. In order to fulfill these tasks, the division will develop, implement, and organize various activities, programs, and projects. In this regard, the division proposes to purchase a portable display system to aid in the more efficient execution of these activities.

II. OBJECTIVE

PIAD intends to acquire a portable display system that is a collapsible booth used for events and exhibits. The purpose of acquiring the portable display system is to support the information dissemination campaigns and presentations for various events, exhibits, and related activities to promote awareness on data privacy.

A portable display system will aid PIAD and the NPC achieve a strong and impactful presence during events. When in use, portable display systems attract booth visitors and convey the Commission's message, services, and latest work to its stakeholders.

In addition, a portable display system is highly versatile and easy to transport and assemble.
