TERMS OF REFERENCE FOR THE PROCUREMENT OF PRIVACY AWARENESS WEEK JACKET, CUSTOMIZED

I.BACKGROUND

In 2018, Philippine President Rodrigo Duterte issued Proclamation No. 527 declaring every last week of May as the National Data Privacy Awareness Week. This is in recognition of the "need to inform and educate the public about data privacy, data protection and fair information rights and responsibilities as part of reinforcing the efforts of the National Privacy Commission (NPC) in protecting personal data and ensuring the country's compliance with international standards set for data protection."

The country's observance of the Privacy Awareness Week or PAW is also aligned with the annual effort to draw public attention towards privacy issues and the importance of protecting personal information across member countries of the Asia Pacific Privacy Authorities (APPA). This year, the Philippines will officially celebrate PAW in solidarity with other APPA members and other privacy adherents all over the world.

For 2021, the NPC will once again organize its flagship event – the National Data Privacy Conference – to celebrate PAW. Gathering data protection officers (DPOs) and data privacy professionals and advocates, the conference will be a venue to discuss industry-specific issues and capacitate stakeholders with the necessary skills and knowledge.

Organizations processing personal data are also expected to get into the PAW festivities in their own way, and celebrate data subject empowerment all week long with special treats for their customers, members, and employees.

II. OBJECTIVE

The PAW 2021 celebration aims to:

- promote and raise awareness of privacy issues and the importance of protecting personal information among personal information controllers, personal information processors, and data subjects;
- develop the capability and competence of DPOs towards global standards; and
- deepen the engagement with data subjects.

Consistent with PAW's objectives mentioned above, the NPC, through its Public Information and Assistance Division (PIAD), aims to procure a customized jacket for the organizers and attendees of PAW 2021.

Providing a customized jacket is a way to solidify the connection between attendees and the NPC as PAW 2021 organizers. A customized jacket allows attendees to support PAW and is also a marketing strategy. As long as attendees wear the customized jacket on different occasions, PAW will get recognition and exposure.


