REPAIR AND INSTALLATION OF GLASS DOORS AND WALLS
(APP Item No. 2022-0135)

I. BACKGROUND

The Administrative Services Division of the National Privacy Commission (NPC) is tasked to support, maintain, and ensure that the operation of National Privacy Commission is functioning as efficiently as possible. In this regard, the Administrative Services Division proposes the purchase of service for the repair and installation of glass doors and walls of NPC offices.

II. OBJECTIVES

To procure service for the repair and installation of glass doors and walls in order to provide a conducive working environment for the NPC employees and officials.

III. SCOPE OF WORK

1. **Twenty (20) pieces Swing Door Repair and Adjustment**
 - To adjust the mechanism on each bracket and hinges, Tightens the screws to operate a swing- door that opens from both directions.
2. **One (1) piece Threshold Replacement**
 - To replace with a similar profile on hand. It should be an inch or two longer than the distance between the door casing's hinge outside edges to trim it for an exact fit.
3. **Five (5) pieces WF Lockset Replacement**
 - To replace the defective WF Lockset
4. *Warranty*
 - a. Warranties against manufacturing defects, as well as parts and service
 - b. Warranty period/s: One Year
 - c. Warranty shall commence upon issuance of the Inspection and Acceptance Report (IAR) by the Inspection and Acceptance Committee and end-user
5. In case of additional works, request shall be submitted and same should be approved first by the NPC before proceeding.

IV. QUALIFICATION OF SERVICE PROVIDER

The supplier shall submit/provide the following documents:

- PhilGEPS Registration; and
- Mayor's/Business permit

V. CONTRACT DURATION

The engagement shall be completed on or before 15 December 2022 which shall commence five (5) days from the issuance of Notice to Proceed.

VI. PAYMENT AND DELIVERY

Delivery shall be completed on or before **15 December 2022**.

Place of Delivery: NPC, 5th Floor, Philippine International Convention Center, Vicente Sotto Avenue, Pasay City, Metro Manila 1307

Payment shall be made when the Goods have been delivered in accordance with the signed contract/purchase order and instructions and upon issuance of Inspection and Acceptance Report (IAR) by the Inspection and Acceptance Committee and Certificate of Acceptance of output issued by the end-user.

This shall be procurement of Service.


